

## Vegemi Method License Terms & Conditions

### 1. Licence Overview

A Vegemi Method License, covering the Seed, Nourish and Thrive License options, grants customers limited, non-exclusive, and non-transferable access to Vegemi educational resources for the sole purpose of use within the designated educational settings. The resources provided under this licence are intended for educational purposes only and are strictly governed by the following terms and conditions.

### 2. Permitted Use

The Vegemi resources provided under Licence may only be used by the licensed customer for educational activities within the specific classroom, nursery, or school setting for which the licence was granted.

The materials may be printed, used in lessons, and shared with students and parents within the scope of the licensed educational institution.

The Vegemi resources provided under Licence may only be used for the duration of the Licence, as stated in the invoice issued for each licensed customer.

For the Vegemi Method Seed Licence, which is free of charge, use is permitted only for a duration of 30 days.

### 3. Restrictions on Use

**No Commercial Use:** Vegemi resources provided under License may not be used for any commercial purposes, including but not limited to resale, distribution, or offering paid services using the materials.

**No Replication or Distribution:** Customers are prohibited from reproducing, copying, modifying, or distributing Vegemi resources beyond what is explicitly permitted under the licence. This includes digital or physical replication.

**No Sharing with Unlicensed Parties:** Resources must not be shared, distributed, or made accessible to any third party, including other schools, educators, or institutions that do not hold a valid Vegemi License.
